STEAM study tour packages 2025 – 2026

Tender specifications for the services of providing an overseas study tour package for STEAM study tour

Introduction

This tender outlines the proposal for a STEAM (Science, Technology, Engineering, Arts, and Mathematics) study tour to Singapore. The purpose of this tour is to provide participants with an immersive experience that enhances their understanding of STEAM principles through guided visits, practical and experiential workshop workshops to various institutions

- 1) To improve participants' knowledge and skills in STEAM subjects through guided visits and hands-on workshops to various institutions.
- 2) To encourage innovative thinking by exposing participants to Singapore's technological advancements and artistic initiatives.

The package shall include **A)** a 6-day overseas study tour, **B)** pre-tour briefing sessions, **C)** promotional support and **D)** learning support. Details of the package include:

A) Study tour to Singapore

1. The service provider has to co-plan a **6-day itinerary to Singapore** with two teachers, which can relate with the above aims.
2. The itinerary should be led by **at least one** Hong Kong government registered tour guide.
3. The targeted regions are planned to be Singapore.
4. The targeted participants are planned to be **around 20 – 30 F.3 to F.5** students, with **2** escorting teachers.
5. It is planned to be held within the period from **30th March to 6th April 2026 (6 days)**.
6. The proposed activities drafted by teachers:
 - 6.1 Include following visits/ activities:
 - Science Centre Singapore
→ if possible, arrange specialized workshop, such as DNA lab. or Robotics lab.
 - Singapore Discovery Center
 - Marina Barrage and the URA City Gallery
 - Changi Jewel Rain Vortex
 - Art Science Museum
 - Night Safari
 - Visit to wetland (e.g. Sungei Buloh Wetland Reserve or Pulau Semakau)
 - Lee Kong Chian Natural History Museum
 - Supertree Grove and Garden Rhapsody
 - Other visits/ activities related to Art & Architecture Integration: architectural visits (e.g., Esplanade – Theatres on the Bay, Helix Bridge)

6.2 Please reserve either a morning or an afternoon slot on one of the tour days for a potential visit by our school to Maris Stella High School, allowing for an exchange between students from both schools. However, this item is still pending confirmation. Should our school be unable to arrange this exchange activity, your organization is required to arrange an alternative itinerary for the students.

Regardless of whether the exchange activity takes place on that day, your organization must arrange lunch for all participating teachers and students.

6.3 At least **two practical and experiential workshop** related to STEAM in local professional organization or education institution.

6.4 Any other activities which are relatable / meaningful / educational / interesting to Hong Kong secondary school students or visiting places that have catholic and cultural elements.

7. For all the above activities mentioned in point 6:

7.1 The tour guide provided by the service provider shall be able to explain to our students the educational value(s) and learning objectives of the sites visited and activities taken part during the tour.

7.2 **All fees (e.g. transportation, 3 meals per day, entrance fees, workshop fees, learning materials, etc.)** should be included in the tender.

8. The tender provided should include the **flight cost** (round trip, economy class, direct flight ticket, with fuel surcharge and airport tax) and **accommodation**, and the cost of these **two items should be shown separately**.

9. **3 meals per day** should be arranged by the service provider.

B) Pre tour briefing session(s)

1. Before the tour, service provider has to hold **at least one** briefing session for students and parents for preparing the overseas study tour.

C) Promotional support

1. Service provider has to assist the school to organize parent meetings to foster their understanding of the study tour package.

2. Service provider has to provide relative promotion materials including:

- Notices and reminders to parents and students.
- A banner with school logo and name of the tour.
- PowerPoint (or equivalent), pamphlets, newsletters and posters for post-trip promotions to other parents and students.

D) Learning support

1. Provide worksheets/ learning profile or learning handbook to students. Relevant basic background information of the attractions and cultural activities and guiding questions should be included.

General Remarks

1. The following items must be stated clearly in the tender provided:

- The type and name of relevant accommodation during the tour.
- The number and type of meal provided during the tour.
- The type of transportation between different places during the tour.
- The proposed airline and related flight information in the period of **30th March to 6th April 2026 (6 days)**.
- **Direct flight from Hong Kong to Singapore (round-trip ticket) is preferred.**
- The estimated average charge of each student on a group size of
 - ◆ 20 students + 2 teachers
 - ◆ 26 students + 2 teachers
 - ◆ 30 students + 2 teachers
- The charge for the 2 teachers should be shown separately.
- The **travel insurance** per person for the 6-day trip.
